As a key technology partner of HITRUST's Enhanced Indicator of Compromise (IOC) program, Trend Micro believes Nutkis' testimony to the Department of Homeland Security (DHS) will help reinforce the strong need for government and healthcare organizations to continue to deploy advanced threat detection capabilities and build a functioning, transparent process of sharing cyber threat information to mitigate risk for the entire industry.

This hearing will allow for a discussion of DHS private sector engagement and programs to identify what makes particular outreach efforts and products of value to participating entities.

"Trend Micro is an active member of DHS's Cyber Information Sharing and Collaboration Program (CISCP)," said Cabrera. "The exchange of cybersecurity information with the DHS and other government agencies is important because it allows us to work together as a security industry community including members from both private industries and the government."
